

## Notice of Recall – State of Washington

Washington State is conducting a recall due to notification of oyster-associated Norovirus illnesses. This recall pertains to live shellfish harvested from Stellar Bay Shellfish in Canada, BC 14-8, on harvest dates March 7, 8, 10, and 14: <https://recalls-rappels.canada.ca/en/alert-recall/certain-stellar-bay-shellfish-brand-oysters-recalled-due-norovirus>

Stellar Bay sold to one Washington State dealer, Taylor Shellfish, who then sold to the following states: California, Colorado, Florida, Massachusetts, Nevada, New Jersey, New York, Oregon, and Washington.

The shellfish companies who sold Stellar Bay oysters have notified all customers. Below is the Washington State dealer distribution information. We are working with the companies to compile how many of the affected oysters were consumed, returned, or destroyed.
