## EMERGENCY DESIGNATION OF SHELLFISH LANDS IN THE STATE OF NEW YORK AS UNCERTIFIED FOR THE HARVEST OF SHELLFISH AND CARNIVOROUS GASTROPODS

Pursuant to the provisions of Subdivisions 13-0307 (1) and (2), Subdivision 13-0309 (1) and Subdivision 13-0330 (6) of the Environmental Conservation Law and Section 47.4 and Section 50.1 of Title 6 of the Official Compilation of Codes, Rules and Regulations of the State of New York, and due to the presence of marine biotoxins in shellfish which may cause shellfish and carnivorous gastropods, which feed on shellfish, to be hazardous for use as food, I, Debra A. Barnes, Section Head, Shellfisheries Section, Bureau of Marine Resources, Division of Fish, Wildlife & Marine Resources of the Department of Environmental Conservation, hereby designate the shellfish lands described below as **UNCERTIFIED** effective at sunrise on Friday, May 10, 2013, and continuing until a determination is made that marine biotoxins are no longer present at levels that may make shellfish and carnivorous gastropods hazardous for use as food.

**Accordingly, it is unlawful to harvest shellfish and carnivorous gastropods from the following areas:**


**Town of Southampton:** All that area of Sag Harbor Cove, and its tributaries, lying westerly of the northbound lanes of the Lance Corporal Jordan Haerter Veterans Memorial Bridge (Route 114 or Ferry Road) to North Haven.

**Town of Huntington:**

1. All that area of Northport Bay, Northport Harbor and tributaries, including Steers Canal, lying southerly of a line extending northeasterly from the highest point of the green domed cupola of the residence located at 24 Mariners Court, Centerport, on the northeastern shore of Little Neck Point, to the highest point of the gazebo located between the shoreline and the residence at 8 Hawkins Drive, Northport, (local names, local landmarks), located near the eastern shore of Northport Bay AND
2. All that area of Huntington Harbor, including tributaries, lying southerly, westerly and easterly of a line extending easterly from the northeasternmost end of the sea wall protection at the western entrance to Huntington Harbor to the northernmost end of the rock and concrete rubble bulkhead-jetty protecting the eastern entrance to Huntington Harbor, local landmark. **Please Note: The areas designated for closure in the Town of Huntington correspond to the normally uncertified areas of Northport Harbor, Northport Bay, Steers Canal and Huntington Harbor.**
