RE: 2016-2017 Committee Charges

This memorandum is to confirm your appointment by the Conference Executive Board Chairman to the Male-specific Coliphage Committee. Patti Fowler will serve as Committee Chair.

- 1. Proposal 15-102 Guidance Document. The original subcommittee that drafted the proposal is tasked to develop a guidance document for the use of MSC. The draft will be presented to the Executive Board in March for approval. This Subcommittee is being established as a Committee
- 2. Other Items for Committee Discussion Prior to Development of Guidance
 - Inclusion of MSC guidance into Guidance Document "Determining Appropriately Sized Prohibited Areas Associated with Wastewater Treatment Plants" Committee has agreed this approach is more practical than creating a separate guidance document on MSC.
 - The more appropriate placement of the 50msc/100g language would be in the microbiological standard section of Chapter IV. (Addressed in proposed charges)
 - Clarification of which conditional classification is appropriate for MSC use.
 (Addressed in proposed charges)
 - The language of Proposal 13-118 provides a rationale for 1000 to 1 but does not include guidance for other classifications to be used for areas adjacent to WWTP.
 - All of the Public Health Explanation and Guidance Document language should be harmonized in the NSSP Guide to make sure the language is consistent.
