This letter is to confirm your appointment by the Conference Chair to the 2016-2017 Vibrio Management Committee (VMC). The Committee will assess if additional changes are needed in the NSSP Guide for the Control of Molluscan Shellfish Model Ordinance to reduce the risk of Vibrio illnesses.

The VMC is assigned the following tasks for 2016-2017:

- Annually review trends in Vibrio illnesses.
- Collaborate with the Education Committee on Vibrio education issues and recommendations.
- Proposal 13-200 Reducing the Risk of Vibrio Illnesses
 - 1. Continue to monitor the activities and report annually to the VMC regarding the development of a process for using local data including regional or state illnesses and landings information, to more accurately reflect risk in a region or state.
 - 2. Continue to monitor the activities and report annually to the VMC regarding how best to estimate consumption patterns, including collection data regarding the number of shellfish consumed per serving, through market research, endpoint consumer data, or other information gathering methods.
 - 3. Form a subcommittee to evaluate the effectiveness of existing NSSP regulations to reduce risk of Vibrio illnesses caused by improper handling, storing, or transportation of shellstock; to identify areas within the NSSP needing improvement; and make recommendations to the ISSC. The subcommittee will consist of FDA, state and industry representatives. Evaluate existing NSSP regulations to reduce risk of Vibrio illnesses caused by improper handling, storing, or transportation of shellstock and the effectiveness of existing enforcement mechanisms.
