ISSC CONSTITUTION - ARTICLE V. DUTIES OF THE BOARD

Section 1. The Board shall manage the affairs of the Conference. The Board may act on behalf of the voting delegates between voting Conference meetings, in keeping with the spirit and intent of the delegates. Any decision or action taken by the Board which would require voting delegate approval in accordance with the remainder of this Constitution, By-Laws, or Procedures, shall be submitted as a proposal to the next voting meeting for concurrence or correction.

Section 2. The Board shall meet during each Conference meeting and after the voting General Assembly of the regular Biennial Conference meeting. The Board Chairperson shall call special meetings of the Board at any time at the request of two-thirds (2/3) of its members. The Board Chairperson may call special meetings of the Board at any time, as the need arises, with the concurrence of two-thirds (2/3) of the Board members.
