Requested Action:

Whenever the Molluscan shellfish products are deemed to be contaminated with a pathogen that would subject it to a recall, reconditioning of the product will be permitted as an alternative to control the hazard. Any such reconditioning process that is used must be validated to reduce the level of the pathogen in question to a level which is not reasonably likely to cause illness or alter the product to a form that is intended to be cooked.
