Meeting Discussions/Decisions/Action Items:

The meeting was called to order, followed by roll call.

Meeting Minutes: The Laboratory Committee (LC) meeting minutes from January 2017 were approved.

Method/Proposal Tracker: The LC discussed the status of the items on the proposal tracker.

Subcommittee Updates:

Biotoxin Subcommittee. The Laboratory Committee discussed the status of data review for the SRT for ASP and PSP and the RBA for PSP. Draft responses have been prepared by the Biotoxin Subcommittee on these data sets. **Action Item: Stacey will send the latest revisions of the data package responses out to the LC for final review.**
